Acknowledgment of Risk: PLEASE READ

I hereby acknowledge that I have voluntarily chosen to allow my child to attend the 2021 Ubuntu Summer Camp. The activities in which my child may participate at camp include, but are not limited to, slacklining, unicycling, skating, obstacle courses (a form of parkour), capture the flag, dodgeball, and Kubb. There is an inherent risk of injury from the activities involved in this camp. While particular rules, equipment and personal discipline may reduce this risk, the risk of injury exists, including a risk of serious physical injury, emotional stress, and/or death. By voluntarily allowing my child to participate in camp activities and with the knowledge of the risks involved, I hereby agree to accept any risks.

Mandatory Consent, Release and Waiver Of Liability: PLEASE READ

I hereby give permission that the above-mentioned child may be given emergency treatment as needed by staff members of Ubuntu LLC. I also give my permission for my child to be transported by ambulance or aid

car to an emergency center for treatment.
